BYLAW NO. 12-2026

**A BYLAW FOR THE ENTERING INTO AN AGREEMENT WITH THE
SANDY BEACH LAKE REGIONAL PARK AUTHORITY.**

The Council of the Rural Municipality of Britannia No. 502 in the Province of Saskatchewan enacts as follows:

1. The Rural Municipality of Britannia No. 502 is hereby authorized to enter into an agreement with The Sandy Beach Lake Regional Park Authority, the terms of which are set out in Exhibit 'A', which is attached hereto and forms part of this bylaw.
2. The Reeve and Chief Administrative Officer of the Rural Municipality of Britannia No. 502 are hereby authorized to sign and execute the said agreement with the Sandy Beach Lake Regional Park Authority, the terms of which are set out in Exhibit 'A' which is attached hereto and forms part of this bylaw.
3. Bylaw No. 18-2025 is hereby repealed.

AGREEMENT

This agreement made in duplicate this 2nd day of July, 2026.

BETWEEN:

The Rural Municipality of Britannia No. 502 (a
municipal corporation)
In the Province of Saskatchewan
Hereinafter referred to as the "MUNICIPALITY"

- and -

The Sandy Beach Lake Regional Park Authority (a
regional park authority)
In the Province of Saskatchewan
Hereinafter referred to as the "PARK AUTHORITY"

WHEREAS *The Municipalities Act* provides that, the MUNICIPALITY shall collect taxes on behalf of a regional park;

AND WHEREAS *The Municipalities Act* provides authority for the MUNICIPALITY to enter into an agreement;

NOW THEREFORE THE PARTIES HERETO AGREE AS FOLLOWS:

1. The MUNICIPALITY shall provide assessment and tax collection services for the PARK AUTHORITY for the year 2026.
2. The PARK AUTHORITY authorizes the MUNICIPALITY to levy a uniform mill rate of 1.20 Mill(s) applicable to the entire regional park for the year 2026.
3. The PARK AUTHORITY shall pay the MUNICIPALITY a fee of \$130.00 plus GST per taxable lot for the provision of assessment and tax collection services for the year 2026.
4. The MUNICIPALITY shall not administer any Development or Building permits on behalf of the PARK AUTHORITY.
