BYLAW NO. 16-2023

A BYLAW TO REGULATE THE SPEED OF MOTOR VEHICLES

The Council of the Rural Municipality of Britannia No. 502 in the Province of Saskatchewan enacts as follows:

Short Title

1. SHORT TITLE

(a) This Bylaw shall be known as the **Speed Limit Bylaw**.

2. DEFINITIONS

(a) In this bylaw and its schedules:

(i) "Public highway" shall have the meaning ascribed to it by *The Highways and Transportation Act, 1997*:

(a) "**public highway**" means a road allowance or a road, street or lane vested in the Crown in right of Saskatchewan or set aside for the purposes of the Crown in right of Saskatchewan pursuant to *The North-West Territories Act*, or any Act, and includes anything erected on or in connection with the public highway;"

(ii) "motor vehicle" shall have the meaning ascribed to it by *The Traffic Safety Act*:

(a) "**motor vehicle**" means a vehicle propelled or driven by any means other than by muscular power"

3. GENERAL

(a) Signs indicating the maximum speed allowed shall be erected at the commencement of the speed zone area and signs shall be erected showing the end of the speed zone area.

(b) The maximum speeds allowed on a particular road are recorded in Schedules "A", "B", "C", "D" and "E" attached and forming part of this Bylaw.

(c) Any person who contravenes any of the provisions of this Bylaw is guilty of an offense and liable on summary conviction to the penalties in the General Penalty Bylaw of the Municipality.

4. REPEAL

(a) Bylaw #28-2019 is hereby repealed.

Schedule "A"

No person shall operate a motor vehicle at a greater speed than 30 kilometers per hour on that portion of a public highway described as follows:

- a. Being within the Hamlet of Greenstreet.



A BYLAW TO REGULATE THE SPEED OF MOTOR VEHICLES

Schedule "B"

No person shall operate a motor vehicle at a greater speed than 40 kilometers per hour on that portion of a public highway described as:

- a. Being within Border Creek Estates (SW 23-50-28-W3) on the following roads:
  - (i) Dion Place
  - (ii) Robert Drive
  - (iii) Roddy Place
  - (iv) Creekview Road;
  
- b. Being within Kramberry Estates (SW 5-50-27-W3) on the following roads:
  - (i) Lyndon Street;
  
- c. Being within Greenway Subdivision (SE 25-50-28-W3) on the following roads:
  - (i) Greenway Drive;
  
- d. Being within Hillgreen Subdivision (SE 26-50-28-W3) on the following roads:
  - (i) Hillgreen Drive;
  - (ii) Prairie Grove Lane.
  
- e. Being within Debusschere Subdivision (SW 13-51-28-W3) on the following roads:
  - (i) Val-Lee Road;
  
- f. Being within Country Meadows Estates (SW 9-50-27-W3) on the following roads:
  - (i) Country Meadow Lane;
  
- g. Being within the Hamlet of Hillmond;
  
- h. The service road running adjacent to Highway 17 on the west, and the SW 12-51-28 W3 as well as Parcel B, Plan 102022546, Extension 0 on the NW 12-51-28 W3 to the east;
  
- i. Northminster Drive and Northminster Lane located on the SW 12-51-28 W3;
  
- j. Service Road D located on the SE 05-50-27 W3;
  
- k. Buffalo Street located on the SE 01-50-28 W3;
  
- l. Township Road 500 south of Section 06-50-27 W3;

*Schedule "B" continued*

- m. Being with Westbay Estates:
  - (i) Westbay Place;
  - (ii) Westbay Drive.
  
- n. Township Road 501 between Range Road 3265 and 3270;
  
- o. Township Road 520 from Highway 17 east to Sandy Beach Regional Park.



A BYLAW TO REGULATE THE SPEED OF MOTOR VEHICLES

Schedule "C"

No person shall operate a motor vehicle at a greater speed than 50 kilometers per hour on that portion of a public highway described as:

- a. The road allowance located west of the Hamlet of Greenstreet and travelling north east for a distance of 500 metres to the intersection with Range Road 3265, and further, that an advance speed zone sign shall be installed 250 metres west, in advance of the said speed zone;
- b. Range Road 3265 from a point 150 m south of where the road intersects with the road allowance travelling to the east and west of the Hamlet of Greenstreet, and further, that an advance speed zone sign shall be installed 550 metres south in advance of the said speed zone;
- c. The road allowance located 500 metres east of the Hamlet of Greenstreet, and travelling westerly to where the road intersects with Range Road 3265, and further, that an advance speed zone sign shall be installed 200 metres south east, in advance of the said speed zone;
- d. Range Road 3264 for a distance of 1,800 metres north east of where the road intersects with the road allowance travelling to the east and west of the Hamlet of Greenstreet, and further, that an advance speed zone sign shall be installed 200 metres north east, in advance of the said speed zone;
- e. The road allowance located east of the Hamlet of Greenstreet, and travelling south east from Range Road 3265 to Range Road 3261;
- f. The municipal road passing diagonally through section 31-51-25 W3; and
- g. Range Road 3280 between Township Road 503 and Township Road 504.



A BYLAW TO REGULATE THE SPEED OF MOTOR VEHICLES

Schedule "D"

No person shall operate a motor vehicle at a greater speed than 60 kilometers per hour on that portion of a public highway described as:

- a. Range Road 3253 From Hiway #3 to Township Road 522 East of Sections 16, 21 & 28-52-25 W3;
- b. Range Road 3280 adjacent to the west side of Section 13-50-28-W3; and
- c. Township Road 512 north of Section 10-51-27 W3 for a total distance of 375 metres, commencing 100 metres to the east of the division between the east and west quarter section, and a distance of 275 metres west of the division between the east and west quarter section; and
- d. The portion of Primary Grid Road 684 north of NE 23-51-25 W3 and east of NE 23-51-25 W3.

**Schedule "E"**

No person shall operate a motor vehicle at a greater speed than 90 kilometers per hour on that portion of a public highway described as:

- a. Grid Road 774.
