AGREEMENT

This agreement made in duplicate this 23 day of July, 2025

BETWEEN:

The Rural Municipality of Britannia No. 502 (a municipal corporation)
In the Province of Saskatchewan
Hereinafter referred to as the "MUNICIPALITY"

- and -

The Sandy Beach Lake Regional Park Authority (a regional park authority) In the Province of Saskatchewan Hereinafter referred to as the "PARK AUTHORITY"

WHEREAS *The Municipalities Act* provides that, the MUNICIPALITY shall collect taxes on behalf of a regional park;

AND WHEREAS *The Municipalities Act* provides authority for the MUNICIPALITY to enter into an agreement;

NOW THEREFORE THE PARTIES HERETO AGREE AS FOLLOWS:

- 1. The MUNICIPALITY shall provide assessment and tax collection services for the PARK AUTHORITY for the year 2025.
- 2. The PARK AUTHORITY authorizes the MUNICIPALITY to levy a uniform mill rate of ______Mill(s) applicable to the entire regional park for the year 2025.
- 3. The PARK AUTHORITY shall pay the MUNICIPALITY a fee of \$130.00 plus GST per taxable lot for the provision of assessment and tax collection services for the year 2025.
- 4. The MUNICIPALITY shall not administer any Development or Building permits on behalf of the PARK AUTHORITY.
