**BYLAW NO. 31-2025**

**A BYLAW TO ESTABLISH CUSTOM WORK FEES**

The Council of the Rural Municipality of Britannia No. 502, in the Province of Saskatchewan enacts as follows:

**SHORT TITLE**

1. This Bylaw shall be known as the **CUSTOM WORK FEE BYLAW**.

**PURPOSE**

2. The purpose of this bylaw is to establish the fees for custom work performed by the Rural Municipality of Britannia No. 502 on private land located within the Rural Municipality of Britannia No. 502.

**GENERAL REGULATIONS**

3. All fees, charges, and conditions of the municipality performing custom work are set out in Schedule "A" of this bylaw.

**COMING INTO FORCE**

4. This bylaw shall come into force on the date of the third and final reading.
5. Bylaw 11-2025 is hereby repealed.
