

**RURAL MUNICIPALITY OF BRITANNIA NO. 502  
BYLAW NO. 21-2025**

**A BYLAW TO REGULATE FIRE PROTECTION FEES  
CHARGED BY THE RURAL MUNICIPALITY OF BRITANNIA NO. 502**

The Council of the Rural Municipality of Britannia No. 502 in the Province of Saskatchewan enacts as follows:

1. This bylaw may be cited as the "Fire Fee Bylaw".
2. In this bylaw, including this section:
  - a) "Municipality" means the Rural Municipality of Britannia No. 502.
  - b) "Council" means the Council of the Rural Municipality of Britannia No. 502.
3. The cost of fire protection services is to be charged directly to the agency, person(s) or landowner who receives the service.
4. The schedule of hourly fees be set in accordance with Schedule 'A' attached hereto and forming part of this bylaw.
5. In accordance with Section 369 of The Municipalities Act, the Municipality shall add any outstanding fees to the tax roll.
6. That Bylaw No. 18-2023 be repealed.
7. This bylaw shall come into force and take effect upon final reading and adoption.

Schedule 'A' to Bylaw No. 21-2025

1. Hourly fees to be charged for response by the Britannia Fire Department within the RM of Britannia No. 502 or requested mutual aid by a Municipal Operated Fire Department:

- a) Pumper 1..... \$ 200.00
- b) Pumper 2..... \$ 250.00
- c) Pumper 3..... \$ 250.00
- d) Tanker 1 ..... \$ 250.00
- e) Tanker 1 (with pup)..... \$ 350.00
- f) Tanker 2 ..... \$ 250.00
- g) Ladder 1 ..... \$ 250.00
- h) Wildland unit.....\$ 175.00
- i) Side x Side .....\$ 125.00
- j) Command Unit .....\$ 150.00
- k) Per Firefighter.....rate paid firefighters plus \$3.00 for overhead
- l) Foam (Class A or B) ..... Actual cost incurred
- m) Additional Contractors..... Actual cost incurred

2. Hourly fees to be charged for the response by the Britannia Fire Department during a SPSA (Saskatchewan Public Safety Association) request be established as follows:

- a) In accordance with hourly rates established by SPSA (Saskatchewan Public Safety Association) and authorized by the RM of Britannia No. 502.
