



MAIDSTONE RCMP REPORT

For the dates of: December 31, 2025 – January 13, 2026, Maidstone RCMP responded to 90 calls for service, some of which include:

9 traffic collisions
28 provincial traffic offences
4 mischief
0 robbery
0 False 911 call

CALLS FOR SERVICE:

- On December 31st, Lashburn Fire reported single vehicle rollover at Marshall. Members attended, the 61-year-old driver from North Battleford was extracted from the truck and brought to Lloydminster hospital by EMS.
- On December 31st, members responded to at a residence in the RM of Wilton. Caller had an unknown dog in her yard that was scaring their children. Caller had been unable to determine owner. Members attended and brought dog to the shelter in Lloydminster. Dog was later reunited with its owner.
- On December 31st, police received a call about a collision involving a semi driving eastbound on Highway 3 in the RM of Britannia. There were no injuries. The semi lost control and jack-knifed causing the semi's two trailers to jump across both bridge rails causing extensive damage to bridge rails and semi. Semi was driving approximately 80 - 90 km/hr, which was too fast for the snowy/icy conditions. The 30-year-old driver from Edmonton was fined \$205 for driving at a speed that is greater than reasonable and safe.
- On January 1st, 911 received a call of a truck parked in the median just east of Lashburn. Suspected impaired driver. Member made extensive patrols in the area but the vehicle was gone on arrival.
- On January 1st, 911 received a call of a white car with the back bumper falling off, nearly caused a head-on collision, sped off on Highway 45 towards Marwayne, AB. Members advised the Kitscoty RCMP detachment and patrolled the area with Kitscoty RCMP. The vehicle was not located.
- On January 1st, RCMP received a call for a well-being check. Members attended and spoke with a male and determined that there were no immediate concerns that would allow members to act. Members referred the complaint to seek medical attention or a mental a mental health apprehension warrant.
- On January 1st, RCMP received a call of an erratic driver on 16 Highway near Paynton SK. The vehicle was reported to have that almost hit the ditch. Members made patrols but were unable to locate the subject vehicle.
- On January 1st, members received a call from a resident in Paynton that his back and driver side windows were smashed out of his car. File is still under investigation.
- On January 2nd, RCMP received a call of a suspicious vehicle on 16 Highway near Paynton. The vehicle was driving at a slow speed without taillights but had its hazard lights on and had almost driven into the ditch. Members patrolled the area and located the vehicle. The driver was travelling from Manitoba to Edmonton AB and had a fuse blown in the vehicle rendering the taillights and radio inoperable. Driver told to keep hazards on and obtain repair in Lloydminster.
- On January 2nd, 911 received a 911 hangup where a male could be heard in distress in the background. On callback, the caller said the voices were coming from the television and he called accidentally. Members attended and preformed a search of the residence; no one in distress was located.
- On January 2nd, member received a call of an injured moose on Highway 675 near Lashburn SK. Members attended and the injured animal was dispatched.
- On January 3rd, a report was received a report of a truck pulling a trailer that had ice coming off of the trailer. A piece of ice struck the caller's vehicle and damaged their windshield. Suspect vehicle was last seen turning onto 303 Highway near Lloydminster. Members patrolled the area but were unable to locate the suspect vehicle.
- On January 3rd, members received a report of a deceased person in the RM of Eldon. Members attended to assist with Maidstone EMS and the Saskatchewan Coroner's Office. The death was determined to be the result of natural causes.
- On January 3rd, RCMP received a mental health act call for a female engaging in self-harm. The 18-year-old female was provided with emergency First Aid care by members before being transferred to the care of EMS. The female was transported to hospital by EMS for additional treatment.

- On January 4th, RCMP received a call for an unwanted female in a residence in Greenstreet. The 21-year-old female was arrested and removed without incident then held overnight in cells to be released when sober.
- On January 5th, 911 received a call about a female posting on Facebook that she was stranded near Alcurve on 17 Highway. Maidstone RMCP members patrolled the area and conducted a trace on the female's cell phone. The female's cell phone trace indicated that she was in Onion Lake SK. Onion Lake RCMP members were contacted and they confirmed that the female was safe with family.
- On January 5th, members received a report of sexual assault. File is still under investigation.
- On January 5th, RCMP received a black Cadillac driving erratically on Highway 17 in the RM of Britannia. The vehicle was reported to have been swerving across lanes, speeding, and passing on solid lines. The vehicle was located and a traffic ticket was issued.
- On January 6th, members received a report of abandoned luggage on a grid road in the RM of Wilton. Members attended and located the luggage. No persons were found in the area and no identification was found in the bag.
- On January 6th members received a report of a female with no shoes on Highway 16 near Lloydminster. Members attended and found the female with Cenovus Security. Members determined that the female had had a verbal dispute with the other occupants in a vehicle and she was left on the side of the road. Members transported the female to the Lloydminster Hospital for treatment of weather-related injuries.
- On January 6th, members responded to a report of a collision on 16 Highway near Paynton SK. Investigation showed that an adult female driver had struck a moose. No injuries were reported and vehicle was towed.
- On January 7th, a 92-year-old male from Maidstone SK reported that he received an email receipt from Paypal for a \$300 purchase of Bitcoin and that the funds were going to be withdrawn from his account. The male did not have a Paypal account and called a phone number on the email to dispute the charge. The call taker instructed the caller to deposit the \$300 to ensure the payment would clear. Members advised the male that this was a fraud attempt and to not transfer any money.
- On January 7th, a wellbeing check was requested on a female in Lashburn SK as she hadn't been showing up for work. Members investigated and found that the female had been in contact with police in Prince Alber SK.
- On January 7th, RCMP received a call of three unwanted females in a home, possibly using drugs. Member attended and found this to be a family dispute. Members mediated the situation and matter was resolved informally.
- On January 8th, the Roving Traffic Unit spotted a car traveling Eastbound on Highway 16 near Maidstone, SK and stopped it for window tint, leading to the officer seeing unstamped tobacco in plain view. RCMP searched the vehicle and found 4kg of suspected cocaine. The 41-year-old female driver from Edmonton, Alberta was arrested and charged. She will appear in court on March 9, 2026.
- On January 8th, members responded to a collision on 303 Highway in the RM of Eldon. Investigation showed that the driver of an eastbound SUV had been blinded by the headlights of a westbound transport truck. The driver of the SUV drifted in their lane and side swiped the Transport truck. Both drivers were found to be sober and no injuries were reported.
- On January 8th, members received a call of an abandoned SUV on Highway 17 in the RM of Britannia. The vehicle had no lights and was in the driving lane of the highway. Members attended and confirmed vehicle was not stolen. Attempts to contact the owner were unsuccessful and the vehicle towed for the safety of other users of the highway.
- On January 8th, members patrolling on Highway 17 in the RM of Britannia located a vehicle in the ditch. Contact was made with the owner of the vehicle and member assisted in coordinating a tow.
- On January 9th, RCMP were notified of a possible breach of conditions in Lashburn SK. Members investigated and found that there was no evidence to support a breach of conditions.
- On January 9th, the RCMP were notified by an employee of a business in Maidstone SK that an unknown male client made purchase for \$1,180 in lottery and product. The male used an Amazon credit card which turned out to be fraudulent. This file is still under investigation.
- On January 9th, it was reported to the RCMP that there was a male on camera in Lashburn SK who was putting graffiti on a several buildings in the town. File is stil under investigation.
- On January 9th, RCMP were notified of a business in the RM of Britannia being broken into overnight. A 500 lbs propane tank was stolen. The front compound gate was pushed open and the lock was broken. This file is still under investigation.
- On January 9th, members received a call of a wide load semi speeding and passing vehicles at 125km/h on Highway 16 in the RM of Eldon. Patrols were made but the suspect vehicle wasn't located.
- On January 10th, members received a report of an SUV travelling eastbound in the westbound lane near Lashburn SK. Members patrolled the area but were unable to locate the vehicle.
- On January 10th, a Maidstone resident reported that his tires were slashed on his vehicle in his driveway. Member attended and took pictures of vehicle and found pile of screws laid in the driveway. This file is still under investigation.

- On January 11th, members received a report that a stolen vehicle was located near Alcurve on 17 Highway in the RM of Britannia. Contact was made with the owner of the vehicle who declined to have any forensic investigation completed on his vehicle to identify a suspect. Members reviewed security video but were unable to identify any suspects. The owner self-recovered his vehicle.
- On January 11th, members received a call of an SUV driving eastbound in the westbound lane on 16 Highway near Maidstone SK. Members patrolled the area but were unable to locate the suspect vehicle.
- On January 12th, members received report from a parent of a fight between two youths at a school in the RM of Britannia. Investigation showed that the school had already been informed and was dealing with the matter internally. The caller declined to provide a statement and the matter was referred to the school for action.
- On January 12th, members responded to a report of a collision involving a Correctional Canada transport vehicle in the RM of Eldon. The vehicle had struck a moose and not operable. Members from Maidstone and Turtleford Detachments responded. The two prisoners were taken into RCMP custody and lodged at the Turtleford RCMP Detachment until additional transport could be arranged. No injuries were reported. On January 12th, member responded to a report of a death in Lashburn SK with EMS and the Saskatchewan Coroner's Office. Investigation determined that the death was the result of natural causes.

TRAFFIC SAFETY

- On January 10th, a 16-year-old female driver, from Frenchman Butte, SK was found to be going 138 KPH in 100 KPH on Highway 3. The driver received a reduced ticket of \$210 for exceeding a lawfully posted speed limit.

WANTED

Brad MILLARD (50) of Maidstone, Saskatchewan is wanted for two counts of mischief under \$5000-damage to property and failure to appear in court.

Shawn WHITNEY (21) of Waseca, Saskatchewan is wanted for theft under \$5000-theft of gas and failure to appear for court.

Dezmon-Ray ARMSTRONG (26) of North Battleford, Saskatchewan is wanted for assault while choking, suffocating or strangling, uttering threats against a person and failure to appear in court.

Rylan LINDSAY (44) of Neilburg Saskatchewan is wanted for taking a motor vehicle without consent and failure to appear in court.

Stuart MARTELL, 36, of Onion Lake, Saskatchewan is wanted for unsafe storage of firearms, carrying a concealed weapon, unauthorized possession of a firearm/prohibited weapon, possession of firearm/weapon/device ammunition in motor vehicle, adult possession of restricted firearm/prohibited weapon with ammo without licence/registration, fail to comply with release order condition and failure to appear in court.

Jeffrey MCLEAN (41) of Lloydminster, Saskatchewan is wanted for operation while prohibited, possession of property obtained by crime less than or equal to \$5000, pursuit involved – flight from peace officer, dangerous operation of motor vehicle, possession of property obtained by crime less than or equal \$5000, and operation while prohibited.

Justin NOETH (35) of Paradise Hill Saskatchewan is wanted for failing to comply with a probation order and failure to appear in court.

Riley THIESSEN (49) of Shipman, Saskatchewan is wanted for assault with weapon and mischief under \$5,000 – damage to property.

Stanley WHITEFISH (49) of North Battleford Saskatchewan is wanted for operation of a motor vehicle while impaired, operation of a motor vehicle while prohibited, and failure to appear in court.
