BYLAW NO. 14-2025

A BYLAW FOR THE ENTERING INTO AN AGREEMENT WITH THE SANDY BEACH LAKE REGIONAL PARK AUTHORITY FOR FIRE PROTECTION SERVICES.

The Council of the Rural Municipality of Britannia No. 502 in the Province of Saskatchewan enacts as follows:

- 1. The Rural Municipality of Britannia No. 502 is hereby authorized to enter into an agreement with The Sandy Beach Lake Regional Park Authority in order to provide fire protection services, the terms of which are set out in Schedule 'A', which is attached hereto and forms part of this bylaw.
- 2. The Reeve and Chief Administrative Officer of the Rural Municipality of Britannia No. 502 are hereby authorized to sign and execute the said agreement with the Sandy Beach Lake Regional Park Authority, the terms of which are set out in Schedule 'A' which is attached hereto and forms part of this bylaw.
- 3. This Bylaw shall be enacted on the day of its third and final reading.

Schedule A

FIRE PROTECTION SERVICE AGREEMENT

BETWEEN: THE RM OF BRITANNIA (502)
HEREINAFTER KNOWN AS THE "BRITANNIA FIRE DEPARTMENT"
Or "Fire Department"

AND: SANDY BEACH REGIONAL PARK,
Or "Regional Park"

THIS AGREEMENT witnesses that in consideration of the covenants, terms and conditions hereinafter set out, the aforementioned parties do hereby agree to the following:

A. Britannia Fire Department

- 1) The Britannia Fire Department will provide fire protection services, as hereinafter set out to the boundaries of Sandy Beach Regional Beach.
- 2) When the Britannia Fire Department responds to a fire call within the boundaries of Sandy Beach Regional Park, the Fire Department will invoice the assessed property owner for that service.
- 3) Firefighting fees shall be charged by the Britannia Fire Department to all calls attended to within Sandy Beach Regional Park as outlined in Appendix "A".
All additional equipment required to be called in (ie. graders, caterpillars, and or other fire departments, etc.) will be at the discretion of the Fire Chief or Officer in Charge, and billed to each assessed property owner that is affected by the call.
- 4) The Britannia Fire Department will be responsible for their own equipment when providing fire protection services in the said area.
- 5) The Britannia Fire Department will be responsible to respond to only one fire at a time within the Regional Park Boundaries.
- 6) In an effort to prevent unnecessary fire calls to Sandy Beach Regional Park, Britannia Fire Department will administer a burn permit program on behalf of the Regional Park.
Residents of Sandy Beach Regional Park who wish to

B. SANDY BEACH REGIONAL PARK

1. Sandy Beach Regional Park agrees to pay a yearly standby fee of \$3,000.00 to the Britannia Fire Department.
2. Sandy Beach Regional Park guarantees that the Britannia Fire Department providing fire protection within the boundaries of the Regional Park will be paid for that service, including additional equipment required to be called in for assistance.
3. The Regional Park agrees that if the assessed property owner does not pay for the fire call within six (6) months of the billing date, the Regional Park will pay the outstanding balance to the Fire Department.
4. Sandy Beach Regional Park has the responsibility to ensure that the roads, streets and lanes are accessible to Britannia Fire Department. Britannia Fire Department accepts no liability for losses incurred as a result of a fire which due to the conditions of the road, street or lane is inaccessible for the firefighting equipment

It is understood and agreed that this agreement will commence on March 1, 2025.

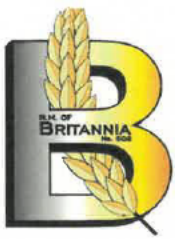
And be **continuous for three (3) years** with either party able to terminate this agreement with thirty (30) days written notice. Rate schedule will be supplied annually or upon any changes
