A BYLAW TO AMEND BYLAW NO. 18-2014 KNOWN
 AS THE LLOYDMINSTER PLANNING DISTRICT ZONING BYLAW

The Council of the Rural Municipality of Britannia No. 502, in the Province of Saskatchewan, enacts to amend Bylaw No. 18-2014 as follows:

Under Section 11 – CON – Conservation District

1. By adding the following to Table 11-1:

Special limitation and standards regarding Table 11-1 and the CON District:

(1) Uses involving hazardous materials or chemicals will be included as a Permitted Use, subject to approval from all government regulatory agencies.

2. This bylaw shall come into force and take effect when approved by the minister.

3. This bylaw shall become effective on the date of final reading and adoption.
