BYLAW NO. 08-2023

A BYLAW TO APPOINT A BYLAW ENFORCEMENT OFFICER FOR ANIMAL CONTROL BYLAWS

The Council of the Rural Municipality of Britannia No. 502 in the Province of Saskatchewan enacts as follows:

Short Title

1. This Bylaw shall be known as the Bylaw Enforcement Officer for Animal Control Bylaw.

Purpose

2. This Bylaw is enacted under the authority of the Municipalities Act, 2005 to promote and develop a safe, healthy, and clean community for residents through the appointment of a bylaw enforcement officer (section 373).

Definitions

- 3. In this Bylaw:
 - (a) **Council:** means the Council of the Rural Municipality of Britannia No. 502; and
 - (b) Municipality: means the Rural Municipality of Britannia No. 502.

Scope

- 4. Council hereby appoints Michael Niesen as the Municipal Bylaw Enforcement Officer for the following Animal Control Bylaws:
 - (a) 20-2002 A bylaw to prohibit the keeping, possessing, or harbouring of dangerous dogs, as amended and replaced;
 - (b) 22-2021 A bylaw with respect to poultry in the hamlets of Hllmond and Greenstreet; and
 - (c) 05-2022 A bylaw to prohibit animals running at large.

General

- 5. The appointment shall commence September 21, 2021 (Motion #533/21) and shall continue until September 20, 2024 unless terminated earlier in accordance with the terms of the Animal Control Service Agreement, Schedule "A" to this bylaw.
- 6. The duties of a Bylaw Enforcement Officer shall be:
 - (a) to enforce all bylaws relating to dogs and cats enacted by the council of the Municipality and at the request of the Chief Administrative Officer:
 - (b) to serve orders, notices and letters at the request of the Chief Administrative Officer;
 - (c) to keep accurate records;
 - (d) to report any suspected contraventions of municipal bylaws to the municipal office;
 - (e) to represent the Municipality before a justice of the peace or provincial court judge in the prosecution of anyone who is charged with contravention of a bylaw;
 - (f) other duties as may be assigned.

Severability

7. A determination of invalidity of any provision of this Bylaw shall not affect the validity of the remaining parts of this Bylaw.

8. Schedule "A" attached hereto forms part of this Bylaw.


