

BYLAW NO. 12-2020

A BYLAW TO AMEND BYLAW NO. 18-2014 KNOWN AS THE LLOYDMINTSER PLANNING DISTRICT COMMISSION ZONING $\underline{\text{BYLAW}}$

The Council of the Rural Municipality of Britannia No. 502, in the Province of Saskatchewan, enacts to amend Bylaw No. 18-2014 as follows:

- 1. The Zoning District Map referred to in Section 13. "Maps" to amend;
 - a. Surface Parcel 135821718 SE 01-50-28W3 Parcel A Plan 101745425 Ext 40 (38.882 ha)
 - b. Surface Parcel 203501450 NE 01-50-28W3 Parcel B Plan 101362306 Ext 17 (48.79 ha)
 - c. Surface Parcel 203501438 NE 01-50-28W3M Parcel C Plan 102295357 Ext 0 (12.701 ha) from A Agricultural District to M1 Industrial District as shown within the red area on Schedule 'A' to this Bylaw.
- 2. This Bylaw shall come into force and effect upon the approval of the Minister of Municipal Affairs
