



MAIDSTONE RCMP REPORT

For the dates of: June 4th – June 18th, 2026, Maidstone RCMP responded to 137 calls for service, some of which include:

132 Provincial Traffic Offences
2 Vehicle Collisions
3 Impaired Operation

CALLS FOR SERVICE:

- June 4th – Lashburn call reporting semi driver pointed something black at her car through windshield; thought it could be a handgun. Semi located & driver detained for weapons investigations. Vehicle searched and no weapons located. No charges laid.
- June 4th - Well being check in Marshall as caller hadn't heard from father in a couple years. Member spoke with subject who said he was not interested in reconnecting.
- June 6th - 911 B&E in progress in Rm of Britannia. Unknown female in residence. Members attended and located person in the house. Subject was arrested, held in custody, then released for a future court date.
- June 6th - 911 iPhone crash notification near Waseca. 911 could hear vehicles passing in the background. No voice contact made. Patrols made of the area but unable to locate a collision or anybody needing assistance
- June 7th -Caller reporting that people have been throwing rocks at his tent from the overpass East of Lloydminster. There are vehicles and people there currently and believes will begin throwing rocks again.
- June 7th – Report of copper wire theft from a business in the RM of Wilton.
- June 7th – Report of assault with a weapon in the RM of Wilton. Investigation has resulted in charges against several individuals for reported assault as well as other unrelated matters.
- June 7th – Caller requested a wellbeing check done on mother in RM of Britannia. Members attended and found no concerns for safety.
- June 8th – Report of mischief in the RM of Maidstone; unwanted person knocking at caller's windows.
- June 8th – Report of a suspicious vehicle in Maidstone. Vehicle parked on side of the street facing the wrong way for the past hour. Members investigated vehicle and found nothing criminal occurring.
- June 8th - Reported break and enter in Waseca. Members attended and found subject matching description in area. Subject was detained for investigation, B&E found to be unfounded. Subject driven to a safe location.
- June 9th - Lloydminster Child and Family Services sent a referral and intake report for a child assault. Investigation ongoing.
- June 10th – Report of person laying beside the highway in RM of Britannia. Members located uninjured intoxicated person. Arrested for being intoxicated in a public place and held until sober.
- June 10th – Call for a wellbeing check in RM of Eldon. Subject had sent concerning messages. Subject located and no concerns for safety found.
- June 11th – Report of B&E in progress at a business in RM of Wilton. Members attended and SOC was gone on arrival. Video of suspects obtained. Investigation ongoing.
- June 11th - Reported fraud at a business in Maidstone. Subject tried paying for items with several stolen credit cards. Security video obtained. Investigation ongoing.
- June 11th – Report of an assault at a business in Maidstone. Two females wrestling over cellphone. Both left the business when asked. Females identified and spoken with. No charges laid as result of investigation.
- June 11th – Report of someone living in an abandoned building in RM of Britannia. Members investigated and believed to be kids playing.
- June 12th – Report of mischief to property in Greenstreet. Caller noticed window of an old vehicle on property had been smashed and pallets by their garage had been moved. No leads or suspects.
- June 12th – Call of person squatting in an abandoned trailer in Greenstreet. Members attended and located no persons inside.
- June 12th – Call of two dogs crossing the highway in RM of Paynton near the Town of Paynton.
- June 12th – Report of child abuse in Town of Marshall. CFS advised and investigation ongoing.

- June 12th – Report of an abandoned vehicle in RM of Wilton. Members attended and found vehicle with several loose parts inside. Nothing criminal noted with vehicle. Calls made to the owner and vehicle left for them to resolve.
- June 13th – Report of disturbance in Rm of Britannia. Caller reported hearing a loud vehicle, people arguing, what sounded like gunshots, then a car door slam and drive away. Members from Maidstone and Onion Lake detachment attended to patrol area. Area searched by vehicle and aerial drone. No suspicious vehicles or person found in the area.
- June 13th – Several calls about a woman walking on highway in RM of Wilton. Woman located and driven to a safe location.
- June 14th - EMS request assistance in RM of Britannia for call of an adult male with mental health issues that may become violent. Members attended with EMS, subject was medically cleared, and left in care of family.
- June 14th - Reporting of a woman walking in Town of Lashburn shouting at herself. Woman located and appeared calm and sober. Woman stated that she was going to her mother's home.
- June 15 - Report of a stolen vehicle in Maidstone. Keys had been left in the vehicle. Vehicle recovered on June 16 burnt in RM of Frenchman Butte. No leads or suspects.
- June 15th – Report of person posting concerning messages on SnapChat in Maidstone. Members attended residence and spoke with poster and family. No immediate concerns, poster left in care of family.
- June 16th – Report of fuel stolen from a work site in the RM of Wilton. No leads or suspects.
- June 16th – Report of harassment Maidstone. Investigation ongoing.
- June 17th - Caller reported he and his brother were fighting at a business in Maidstone. Investigation showed fight was over a girl but all had calmed down. Caller declined to provide a statement. No arrests or charges.
- June 17th – Report of assault in RM of Wilton. Caller reported being assaulted by boyfriend. Investigation brought members to a residence in Lloydminster AB where caller declined to participate in investigation.

TRAFFIC SAFETY

- June 7th – Driver stopped on 16Hwy in RM of Wilton found to be intoxicated by THC. License suspension issued to driver from Willingdon AB.
- June 11th – Report of possible intoxicated driver on 16Hwy in RM of Eldon. Male outside his vehicle appears very intoxicated, went back into his vehicle, almost hit caller from behind. Passed caller, now swerving and going over 140-150kph. Patrols made but unable to locate vehicle. Information sent to neighboring detachments.
- June 15th – Members located a vehicle travelling 149km/h on 16Hwy in RM of Eldon. Driver from North Battleford SK received tickets and vehicle was impounded.
- June 15th – Members stopped a vehicle on 303Hwy in RM of Eldon. Driver had active arrest warrant and failed roadside breath test. Driver from Prince Albert SK charged with impaired operation of a motor vehicle, received license suspension, and vehicle impounded. Driver released for future court date.
