- 5. That the applicant shall be responsible for determining property lines and obtaining line locates (Sask 1st Call, etc...) prior to construction.
- 6. That the applicant receive notification from the RM of Britannia that all necessary upgrades to Township Road 520 have been completed prior to starting construction.
- 7. That the approach shall be constructed within 6 months of the date of receiving notification from the RM of Britannia that construction may proceed.
- 8. Any approach approval is deemed to be a temporary approval, as over time and usage, the circumstances surrounding the approval of the approach may change. Council may require upgrades to the approach corresponding with grater use or they may require the approach to be removed due to alternate access or because the approach is no longer required; and
- 9. All costs to build, maintain, and utilize the approach are to be borne by the proponent, as well as the costs to provide gravel crushed to a size no larger than 1.5 inches.
