SD002-2021 Subdivision Application

R.M. of Britannia #502

NOBLE: That Council acknowledges the subdivision application known as Community Planning File R0086-21S (SD002-2021) for Proposed Parcel A and Service Road on SE 02-50-27W3M. Further, that Council recommends the approval of Proposed Parcel A and denial of the Proposed Service Road, with the following conditions:

- 1. That the Parcel A be extended to include access to Highway 303, while maintaining compliance with Non-Farm Residential site size requirements, and that no Service Road be created.
- 2. That an Approach Approval Application be submitted to the RM for access to the Remaining Parcel from Range Road 3271, or the applicant enter into a registered easement on title of lands to allow for the continued access by both property owners utilizing existing access, or apply for a new access off of highway 303 for separate acces to both property parcels.
- 3. That the fences/ corrals on the east side of Proposed Parcel A be removed/ rearranged to ensure they are all located on Proposed Parcel A or the Remaining Parcel, as required. Further, that all other fences are required to be clearly identified as being on Proposed Parcel A or the Remaining Parcel.
- 4. That a demolition/ building removal permit be obtained from the RM of Britannia and the abandoned residence on Proposed Parcel A be removed, with all existing services decommissioned/removed as well, to the satisfaction of all required approving authorities.
- 5. That a development standard will be added to title of Proposed Parcel A by the RM of Britannia, requiring a drainage plan and proof of compliance with municipal and provincial flood avoidance, minimization, and mitigation standards, namely:
- a. development of new buildings and additions to buildings in the floodway of the 1:500 year flood elevation of any watercourse or water body is prohibited.
- b. any new development in the flood fringe of a 1:500 year flood must be flood proofed to an elevation 0.5 metres above the 1:500 year flood elevation. Where the safe building elevation is not available from the Water Security Agency, it will be the responsibility of the developer to obtain an engineer's report to determine the safe building elevation.
- 6. That the septic tank located on the south end of Proposed Parcel A be
- 7. That the application as reviewed is compliant with RM of Britannia Basic Planning Statement Policy 5.4.4 Site Size and the RM of Britannia Zoning Bylaw Part IV Schedule A (b. 1.b.) Non Farm Residential.
- 8. That the application as reviewed is compliant with RM of Britannia Zoning Bylaw Schedule A – Agricultural/Resource District (A.) (1.a) Principle Uses and (1.e) Non-Farm Residential.
- 9. That the application as reviewed is compliant with RM of Britannia Zoning Bylaw Schedule A – Agricultural/Resource District (B.) (1.a) Agricultural Use.
- 10. That no municipal reserve land is required as per clause 183(a) of the PDA as the proposed is the first and only parcel subdivided from the quarter section.
- 11. That the applicant obtain the necessary approvals and comply with the requirements and recommendations of all government ministries and agencies.
