186/25 Fencing Policy TS-010 Amendment

NOBLE: That council approve the following amendments to Fencing Policy TS-010

- 2(1)d. i. The new fence will consist of four wires and 3" to 4" diameter – six-foot posts, which will be placed 16 feet apart, at a minimum. If the landowner had larger posts or closer spacings, the municipality will replace the new fence with what was existing prior.
- 2(1)d. iii. An upgraded fence may be: a. Where the replacement fence requested in the Right of Way agreement, Right of Entry Agreement, or Temporary Workspace Agreement is of higher quality or for a different purpose than the municipal fence standard;
- 2(1)d. iv. Costs for the upgraded fence shall be based on the current Custom Work Fee Bylaw.
- 3. (2) The municipality is responsible for replacing the fence where damaged once mulching is complete.
- 3. (3) Where a fence is inadvertently damaged, the Operations Director or designate is to be notified immediately and the appropriate repairs will be completed by operations.

And further that these amendments be effective immediately.

187/25 **Mulching Policy TS Amendment**

NOBLE: That council approve the following amendments to Mulching Road Allowances Policy TS-004:

Responsibilities f) ... If it is in the best interest of the municipality to mulch a fence line, to provide safer

sightlines or to provide improvement to the right of way, the municipality will replace the fence that is mulched. Provisions to this work would be on the condition that the RM is not responsible to remove or replace the fence once mulching is complete and any residual mulch, twigs or branches is acceptable to the landowner, if the mulching project does not benefit the municipality.

- The Public Works Staff and/or any contractor hired under agreement, are responsible to be aware of, ...:
 - a) Understanding that mulching works may only take place between August 31 and March 15 without an environmental bird sweep be completed prior to mulching. If mulching is to be done between March 16 and August 30, a bird sweep must be completed prior to mulching... g) If a fence within the mulching area has been inadvertently damaged, contacting the appropriate person and/or the Operations Director or designate to report the damage, so that the damage may be repaired.
- 2 (2)(d) Private fence lines in areas where mulching is to take place, provided the landowner is in favour and signs a written agreement allowing the RM to do this work. The RM is not responsible to remove or replace the fence once mulching is complete, nor is responsible for any residual mulch, twigs or debris left behind, if the mulching does not benefit the municipality. If the mulching benefits the municipality by providing safer sightlines or improvement to the right of way, the municipality will replace the fence in accordance with Policy No. TS-010 section 2 (1) d. i.


