A BYLAW TO AMEND BYLAW NO. 17-2014
KNOWN AS THE LLOYDMINTSER PLANNING DISTRICT COMMISSION OFFICIAL
COMMUNITY PLAN

The Council of the Rural Municipality of Britannia No. 502, in the Province of Saskatchewan, enacts to amend Bylaw No. 17-2014 as follows:

1. The Future Land Use Concept Map referred to in Section 7. "Maps" to re-designate

 - c. Surface Parcel 203501438 NE 01-50-28W3M Parcel C Plan 102295357 Ext 0 (12.701 ha)
 from Agriculture Policy Area and Highway Corridor Policy Area to Industrial Policy Area in the as shown within the red area on Schedule 'A' to this Bylaw.

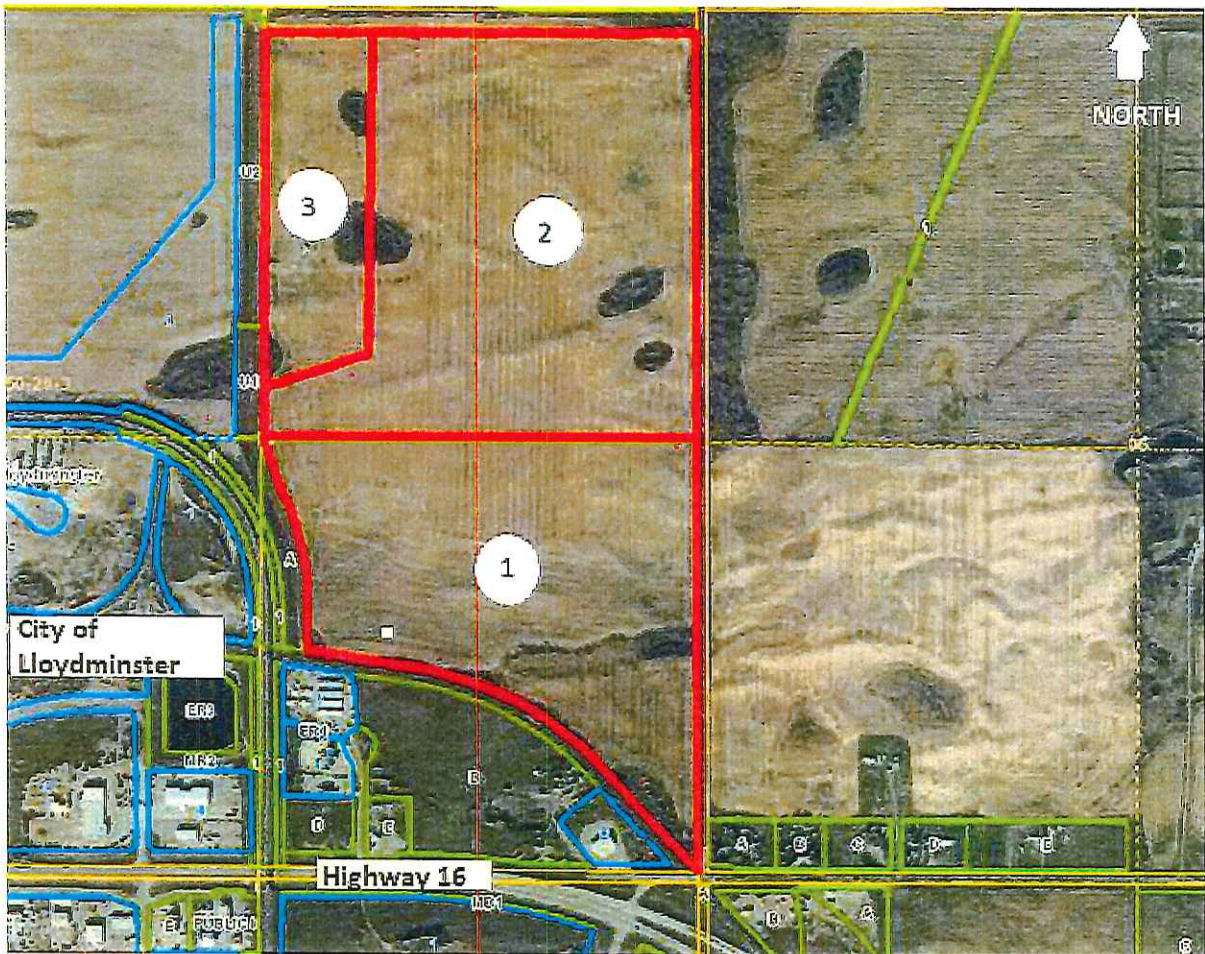
