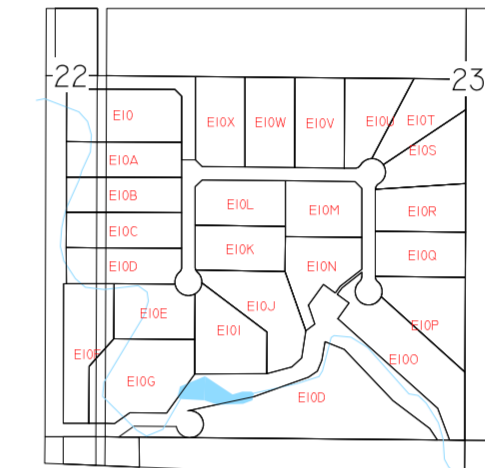

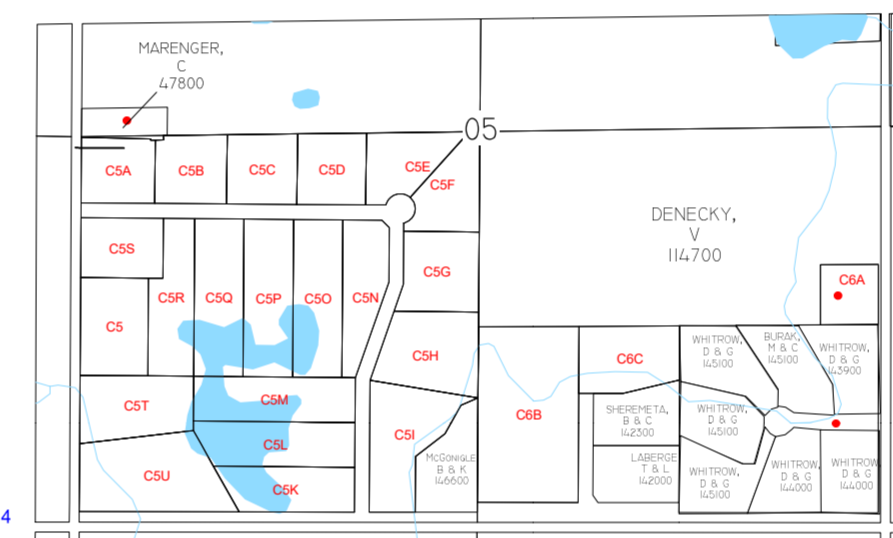

SW 23 - 50 - 28



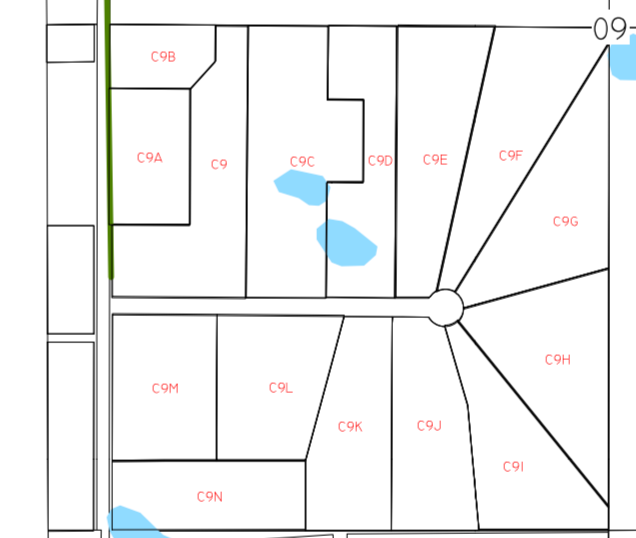
DETAIL " B "

SW 05 - 50 - 27 & SE 05 - 50 - 27



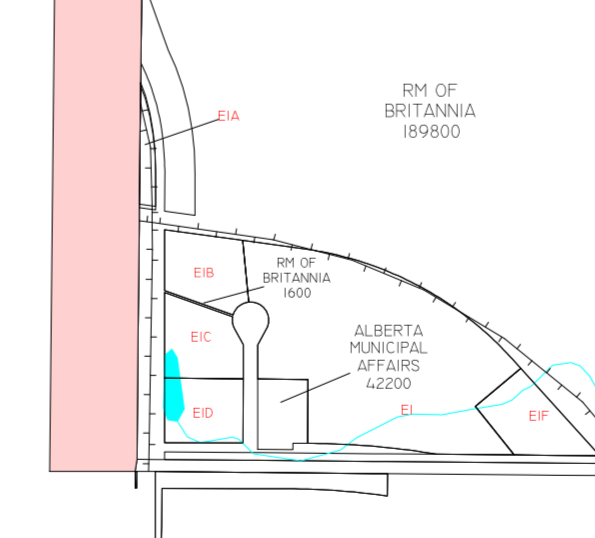
DETAIL " C "

SW 09 - 50 - 27



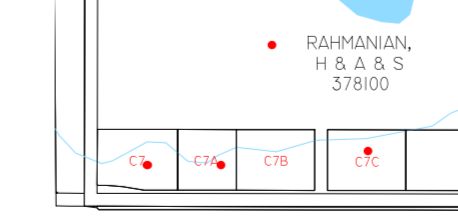
DETAIL " G "

SE 01 - 50 - 28



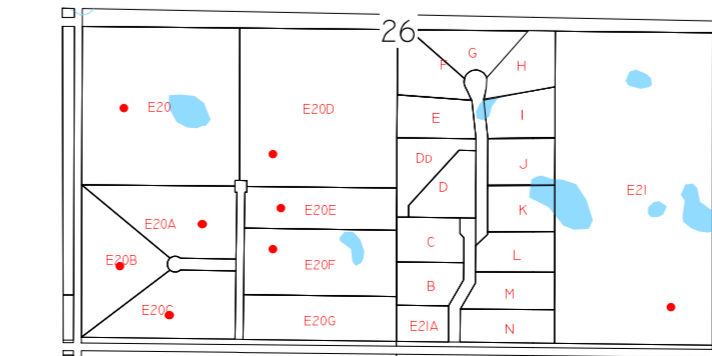

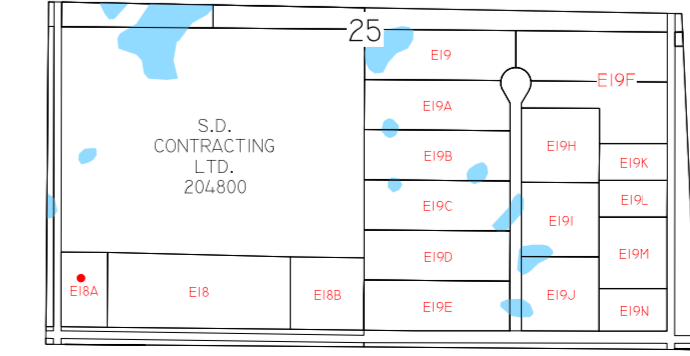
