

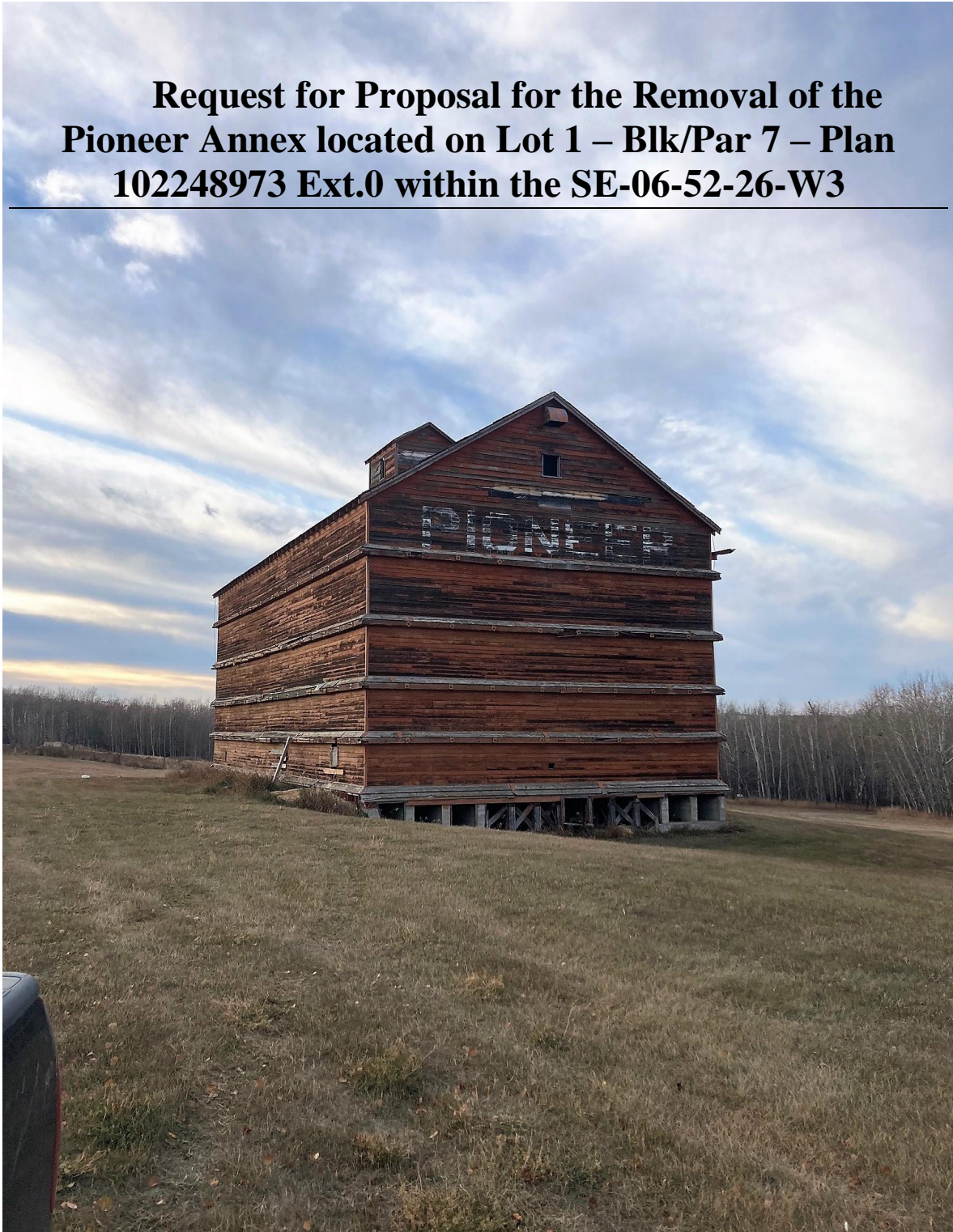

Overview:

The R.M. of Britannia No. 502 is requesting interested parties to submit a proposal to the R.M. of Britannia No. 502 by **March 31, 2022 at 4:00 p.m.**, for the removal of the Pioneer Annex located on Lot 1 – Blk/Par 7 – Plan 102248973 Ext.0 within the SE-06-52-26-W3.

Any interested party is to submit a proposal to the R.M. of Britannia No. 502 in regards to the removal of the large wood structure from the location. The R.M. of Britannia No. 502 is seeking someone that would move the structure as one piece or in several pieces from the parcel of land.

The cement foundation is not the responsibility of the contractor and will be removed by the R.M. of Britannia No. 502.

Building Description:

The building consists of a wood structure with the approximate dimensions being 40-feet wide by 70-feet long by 40-feet high. The building has 4 separate compartments that were utilized for storing cereal crops. There is painted wood siding and, in the interior, there is natural lumber that seems to be in good condition. There is a steel cable structure that was utilized to prevent the wood walls from being pushed out by the weight of the grain. Please see pictures in Attachment "A".

Insurance:

The contractor must have a minimum of 2 million dollars in liability insurance which must be submitted prior to work commencing.

Deadline:

Please submit a proposal that indicates the dollar value you are paying for the building or the dollar value that you are requesting for the removal of the building. Also indicate the anticipated time frame to complete of the building removal, with a deadline of no later than **May 31, 2022**.
